*234. SHRI BAIJAYANT JAY PANDA:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether the Scheme "Strengthening Education among ST Girls in Low Literacy Districts" is being run in various States/ UTs of the country including Odisha;
- (b) if so, the details thereof; and
- (c) the details of the fund sanctioned, allocated and utilised under the said scheme and the time by which the remaining amount is likely to be sanctioned and allocated to the States/UTs, State/UT-wise especially Odisha?

ANSWER

STATEMENT REFERRED IN REPLY TO PARTS (a) to (c) OF THE STARRED QUESTION NO *234FOR ANSWER ON 14.03.2016

- (a) Yes, Madam. The Ministry of Tribal Affairs implements a Central Sector scheme of "Strengthening Education among ST Girls in Low Literacy Districts" for Tribal Girls throughout the country including Odisha.
- (b) The scheme viz., "Strengthening Education among ST Girls in Low Literacy Districts" is exclusively for ST girls in 54 districts identified in the country, where the ST population is 25% or more and ST female literacy rate is below 35% or its fractions, as per 2001 Census. The scheme is being implemented through voluntary organisations/Non-Governmental Organisations and autonomous societies/institutions of State Government/Union Territory Administration and aims at enhancing the literacy rate of tribal girls, bridging the gap in literacy levels between the general female population and tribal women, in order to enable them to participate effectively in and benefit from, socio-economic development.
- (c) The details of funds released to the voluntary organisations/Non-Governmental Organisations and autonomous societies/institutions of State Government/Union Territory Administration, including those in Odisha, during the current financial year 2015-16 under the scheme is given at Annexure I(A).

Funds under the above scheme are not allocated State/UT-wise. However, the overall funds allocated under various schemes, including the scheme "Strengthening Education among ST Girls in Low Literacy Districts",in the current financial year 2015-16 is given at Annexure I (B).

The receipt of proposals from the voluntary organisations/Non-Governmental Organisations and autonomous societies/institutions of State Government/Union Territory Administration, for grant of funds under the scheme is an ongoing and continuous process. Funds are released only if the proposals are complete in all respects including Utilization Certificates in respect of previous grants and subject to availability of funds under the scheme in a particular year.
